Healthwatch in GM

At the most recent meeting we heard from the GM Resilience Hub (and thank you to Sam for arranging this), which relates to our own engagement project. It was clear that health and care staff feel pressured. There was a willingness to extend their work to HW volunteer officers who in turn can use this to support volunteers. My own view is that COVID and its aftermath has put a premium on management and leadership, and highlights the importance of staff resilience.

The Right Care Right Person initiative is not going to plan, with delays and issues.

HW Trafford have set a good example for their leading of the Children and Young Person project and HW Rochdale are due to lead on the forthcoming Menopause project. For both projects there is modest funding linked to tasks to help deliver the project.

Greater Manchester Mental Health Foundation

We received a briefing on the Shanley report on 25th January and copies of the report when published. The report highlights the importance of patient voice. This will continue to be a key part of our planned work going forward and we will also look for further opportunities to promote patient, family and carer voice within the Trust. Sam and I are attending a GMMH Healthwatch meeting the morning before the Board meeting, which will include issues arising from the Shanley report, and we will report back that afternoon.
