HWS TEAM UPDATE

Mark

Deaf Champions – Silent Voices

A session was held with champions on 26th May, where they looked at the wording and structure of the BSL feedback page on our website. Amendments will be made to the website off the back of this.

A focus group session for the GP project has also been done, finding out from the d/Deaf community what the barriers are and what their ideas are to improve on these.

Group support for the Healthwatch England Accessible Information Survey that was due to close was also provided.

A video with d/Deaf champion and Yellow Jigsaw is being arranged and procedures (communication and BSL interpreters) to be agreed.

GP Survey

Mark is working on collating the feedback from the GP Surgery survey. As at the end of May response figures were - **747** completed, **723** partially completed (approx. 150 of these contain data that we can use) and **52** staff surveys. The public engagement phase of this ended on 31st May, however, we continued to receive feedback after this, so the actual numbers for responses are closer to 1000.

Mark met with a group of volunteers last Friday to start the preliminary collating and analysis of feedback. First draft of the report is due the end of July.

Community Forum/Adult Mental Health

The final community forum in this series was held on 24th May in the evening. It was the first truly hybrid meeting we have held with 5 members of public in attendance at Eccles library and 5 others joining us remotely online. The theme for this meeting was around mental health and we welcomed an insightful presentation from Mind in Salford who talked about the services that they offer.

We used the opportunity as a scoping exercise for our forthcoming project around adult mental health, to gather what the people of Salford think we should be focussing on. From this we came away with 7 themes to consider:

These themes were discussed in a meeting with the (then) CCG and project scoping exercise to be completed off the back of this.

Mark (with Ali) has started the planning stages of the care home Enter and View project.

Mark and I attended Salford Pride Pink Picnic and gained more feedback for the GP Survey. I really enjoyed this and found it really helpful and learned more about engagement from Mark.

Ali

Homecare Report

Ali has completed the first draft of the Homecare report and has received feedback from commissioners. Ali has received preliminary feedback from the last commissioner but is awaiting a detailed response before it can then go to sign off.

Equipment Services Report

Report was published last year. A few amends made recently.

Ali (with Mark) has started the planning stages of the care home Enter and View project.

Ali met with Salford Parent Carers group in preparation for the CAMHS/Young Persons Mental Health project.

Ali was involved in engagement activity for Carers Week and supported the CCG with a Dementia event.

Scarlett

One volunteer induction took place in the period with one volunteer in attendance. One informal chat took place with a prospective volunteer who wants to get involved in Youthwatch.

We were unsuccessful in setting up a focus group on GPs for young people to attend, despite reaching out to our links with professionals in Salford. We will focus on building our connections with existing youth groups and continuing to promote what we want to achieve with Youthwatch.

Whilst there are a lot of volunteers on our records now, many are inactive. This is being reviews, so its likely the number of volunteers will go down in the next period, so we have a list more representative of volunteers who are active.

Currently aiming to have a first draft of the Speak Up Salford Fund report by August 2022.
