We continue to mourn the loss of Mark – we're still receiving messages about how well thought of he was across Salford the impact he made both as a person and the work he undertook. Again, I want to acknowledge the work Elyse undertook whilst I was away on annual leave. As well as being colleagues, Mark and Elyse were close friends, and I know losing him has been absolutely heartbreaking for her.

The Just Giving page is still open for donations. As of 23<sup>rd</sup> September, the total donated stands at £1830, plus in person donations made at Mark's funeral.

**Impact -** on receiving the Communications report completed by Mark, NCA have confirmed that they have now added an additional homepage link to the PALS/Complaints section of the Northern Care Alliance website.

We met with Jenni and reviewed all the work we currently had on and planned to pick up – included with papers is a 'work planning document' showing the output of this meeting. I will share this with our commissioner after the board meeting. I will update this document for future board meetings.

## **Companies House**

From 18 November 2025, all company directors and people with significant control (PSCs) will be legally required to verify their identity under the Economic Crime and Corporate Transparency Act 2023. This requirement is part of wider reforms to help prevent the misuse of UK companies.

18 November marks the start of a transition year where all directors must verify their identity before filing their company's next confirmation statement.

For example, if your company's confirmation statement is due on 31 March 2026, all directors must be verified by that date. If you do not do this, your company will not be able to submit the filing.

Our next confirmation statement is due by 11<sup>th</sup> May 2026. This is something that I have delegated responsibility to do.

You can verify your identity for Companies House by using the 'Verify your identity for Companies House' service. This service uses GOV.UK One Login to verify your identity: Verify your identity for Companies House now

GOV.UK One Login will ask you a few simple questions to work out the best way for you to verify your identity online. The options available may depend on your device, whether you have photo ID, and the type of ID you have. Find out more about proving your identity with GOV.UK One Login
