<u>Salford Men's Mental Health Commission</u> - As a result of recommendations by the commission, Salford CVS have released funding for organisations to apply for. We will be reviewing the recommendations made by the commission during the Autumn. Membership for the commission is now being wound down due to other priorities.

<u>Silent Voices</u> - The group continues to meet on a bimonthly basis, with key stakeholders attending to capture feedback and experiences from the group. The membership of the group has been opened up to cover Greater Manchester, which we facilitated via the HW in GM network.
